PROGRESS REPORT ON LIFT INSTALLATION AND RENOVATION OF THE GENTLEMEN'S TOILETS.

Many of you would have seen the work going on in the Town Hall especially those members of the public who cut through from North Street East to High Street East. May I remind you that there is no public right of way down the passageway; notices are posted at each end confirming this.

The work is on schedule and should be completed mid August and when completed the lift will enable those persons with a disability to access the chamber.

This work is being funded by a grant of £50,000 from WREN, which is a not for profit business that awards grants for community projects from funds donated by Waste Recycling Group (WRG) to Landfill Communities Fund.

CO-OPTION TO A CASUAL VACANCY ON UPPINGHAM TOWN COUNCIL

Owing to the resignation of Michael Wellen.

Qualifications for eligibility are;

- a person is qualified to be elected and to be a councillor if he/she is a qualifying Commonwealth citizen or a
 - Euronational, if on the relevant day is 18 years of age or over and:
- be a local government elector for the area of the authority; or he/she has during the whole of the twelve months pre ceding that day occupied as owner or tenant any land or other premises in that area; or his principal or only place of work during that twelve months has been in that area:
- or in the case of a member of a parish or community council he has during the whole of those twelve months resided either in the parish or community or within three miles of it.

Persons that are **not** eligible:

- is the subject of a bankruptcy restrictions order or interim order (as section 267(1) of the Enterprise Act 2002); or
- has within five years before the day of election or since his election been convicted of any offence and has had passed on him a sentence of imprisonment of at least three months (whether suspended or not) without the option of a fine; or
- has been found guilty of corrupt or illegal practices.

If you would like to be considered to be a member of Uppingham Town Council, please submit a personal profile, either by letter of email to the Town Clerk by Wednesday 8th August 2012.

The members or Uppingham Town Council will consider and interview all prospective applicants after that date.
