Item 19 - Consider the four proposals to be included in the proposed parking restriction changes being implemented by Rutland County Council.

2014 Planned Changes - A number of Parking Changes were shared by RCC for 2014 and these will start to be implemented in October with the road markings being completed. Signage will then be commissioned and installed in early 2016 at which point the new restrictions will be enforced. Suitable notices will be displayed in early 2016 to advise residents and visitors. Between now and then questions may be raised about those areas other than double yellows until the signage is in place.

2015 Proposals – The following proposals require consideration with the Town Clerk providing feedback to RCC post 7th October 2015. These requests are from residents / businesses in Uppingham.

Proposal 1 - Station Road, Uppingham (Appendix 1)

Add double yellow lines to the narrow bend just past Arnold Will's factory to improve visibility for vehicles travelling up Station Road and out of the industrial units to the right and left.

Proposal 2 - Springback Way, Uppingham (Appendix 2)

Add short stretch of double yellow lines opposite 4 and 6 reducing the number of cars parked outside one individual's residence and improving the turning space for drives opposite.

Proposal 3 – Adderley Street, Uppingham (Appendix 3)

Add a short stretch of double yellow lines immediately opposite number 9 Adderley Street, Uppingham.

Proposal 4 – Leicester Road, Uppingham (Appendix 4)


Add double yellow lines to prevent the parking of school buses between Queen's Road and Lime Tree Avenue improving the line of visibility for cars pulling out of either junction. Council passed a resolution earlier this year to request 2 hour restricted / permit parking. This doesn't resolve a visibility issue whereas double yellow lines would.

This does mean that the buses would look to park elsewhere in town where there aren't any restrictions, as there is no provision in town for school buses.

Notes:

- There are no other proposals outstanding for changes to the road markings and parking restrictions in Uppingham.
- The much talked of need to address the flow and volume of traffic on Springback Way is a topic to be addressed with Neil Tomlinson at RCC. Town Clerk to add this to a schedule of items.
- Car Parking Permits for Residents in Town Centre car parks UTC have been asked to submit a proposal formally for consideration by RCC as to how this would work, what the parameters are and how it would be funded. Town Clerk to add to a schedule of work to do.




Double Yellow Lines
