Item 6a - Bowls Club Request for Grant Aid (Amenities Committee)

Consider the next steps and response to the Uppingham Bowls Club following a request for Grant Aid support earlier this year.

a) Consider and agree a recommendation to full council in respect of the Grant Aid request for £1,500 from Uppingham Bowls Club submitted on 1st July 2015 (resolution 113/15 1st July 2015).

The Standing Orders permit the following once a debate has taken place on the Options below:

Section 7 of Standing Orders of UTC. Previous Resolutions:

a) A resolution shall not be reversed within six months except either by a special motion, which requires written notice by at least eight councillors to be given to the Proper Officer in accordance with Standing Order 9 (Motions that need to be given by a Proper Officer), or by a motion moved in pursuance of the recommendation of a committee or a sub-committee.

Important Note: The options have been set out this way such that a degree of certainty is given to the Bowls club and Council in turn about the short to medium term – rather than having the issue be raised annually with the outcome being unknown. It allows for the bowls club to plan and budget as well as the Council.

Council may wish to consider some caveats to the ongoing support annually to the Bowls Club (these are just suggestions):

- Actively seeks new members through planned activities in Uppingham and surrounding villages to increase awareness of what is on offer.
- II. Offers incentives for others to join in specific age groups
- III. Looks to promote a greater mix of ages playing the sport by using offers to younger generations
- IV. Looks to secure other means of support to keep the club viable for the longer term

Following the submission of our application for funding on 23rd June last and our subsequent conversations I enclose information to supplement that already provided.

The latest Summary of the Cub Accounts [copy attached] shows the current position.

During the 12 months upto 31st August 2015 over £6000 has been spent on maintaining the premises.

Under the terms of The Lease we are obliged to bear all the costs of keeping the premises in good order.

The funding for this has been met from Reserves which have been built up over very many years.

In the near future there will be more costs for items such as external painting, roofing and the playing carpet.

The premises are wooden and of considerable age. It is essential that these recieve regular maintenance and the costs are greater than traditionally built structures

It is now apparent that if we to continue to carry on this policy without introducing crippling increases in subscriptions etc we will no longer be able to maintain a prudent level of reseves for these on going costs..

The Club do hope the Council will be able to make us a grant.

The matter of the previous funding request and the lease are going back through our committees in October along with a look at the other two clubs as I stated in our call a few weeks ago.

Ahead of this being revisited it would be helpful if you could provide a little more information that will help me when the discussions commence – I was about to contact you about this so your letter and updated accounts are very timely.

These are some of the points it would be good to get a view on to understand a little more of the background:

- 1. Could you give me details of the current membership numbers (male/female) and what has happened to the membership between 2012 and 2015 numbers wise
- 2. Could you let me have the cost per member and what you charge in terms of green fees and for both these items possibly what levels they have been set at for 2012 through to 2015
- 3. I see that you had grants of £2,000 I assume that £1,500 was from UTC, whereas have you obtained grants from before and are these sources still available?
