We would like to purchase equipment for the dance school to be used in dance lessons at Uppingham town hall. This equipment will enhance and improve learning, enabling the dancers to challenge themselves further with their technique, timing and overall performance.

We would like to order 4 portable dance mirrors that can be moved to different parts of the room easily, two ballet barres that are adjustable in height (the dancers currently use chairs, which are not ideal). Finally we would like to order a crash mat for use in acrobatics so that that children can challenge themselves to learn walkovers and back overs with a safe cushioned landing.

The children and adults who attend Curtain Upp Stage School would benefit hugely from the use of dance mirrors, a sturdy ballet barre and the crash mat. These items will give them more confidence as dancers and allow them to work to their true potential without constraints.
