5. If the election is contested, the poll will take place on Thursday, 4<sup>th</sup> May 2023 between the hours of 7am and 10pm.
6. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Monday, 17<sup>th</sup> April 2023. Applications can be made online at [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote).
7. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at the address shown below by 5pm on Tuesday, 18<sup>th</sup> April 2023.
8. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on 25<sup>th</sup> April 2023. Applications for a Voter Authority Certificate can be made online at [www.gov.uk/apply-for-photo-id-voter-authority-certificate](http://www.gov.uk/apply-for-photo-id-voter-authority-certificate)
9. Applications to vote by proxy must reach the Electoral Registration Officer by 5pm on Tuesday, 25<sup>th</sup> April 2023.
10. Applications to vote by emergency proxy at this election must reach the Electoral Registration Officer by 5pm on Thursday, 4<sup>th</sup> May 2023. The physical incapacity must have occurred after 5pm on Wednesday, 25<sup>th</sup> April 2023. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 25<sup>th</sup> April 2023.
